Subject: Recommended wording for the Transportation Reauthorization Bill

Dear Chairman Mica:

We deeply appreciated the presentations by you and your committee staff, Dan Veoni, at the 12th Annual National Association of State Highways and Transportation Unions (NASHTU) Conference in late May. At the conference, you encouraged NASHTU's input on cost savings and public safety measures for the Surface Transportation Reauthorization. We have two recommendations for language to include in transportation authorization:

- **Public performance of construction inspection on surface transportation projects**
- **Ensuring cost-effectiveness of surface transportation projects by requiring a cost comparison prior to outsourcing**

Public Performance of Construction Inspection

NASHTU's suggested wording is found within H.R. 328 (Filner – D-CA). This legislation can be condensed and included in the authorization as follows: **“public employees shall carry out the construction inspection functions for all surface transportation projects receiving Federal funding.”**

On transportation projects, construction inspectors are the eyes, ears and voice of the public. Inspectors ensure that construction standards are met, that projects meet safety requirements and that materials used will stand the test of time.

Public inspectors ensure that construction and seismic standards are met, that projects meet safety requirements and the materials used will stand the test of time. Unfortunately, departments of transportation are outsourcing public inspection with disastrous results, including the collapse of the ceiling tile in Boston's Big Dig tunnel, the collapse of the Minneapolis Bridge over the Mississippi River, and the collapse of Hollywood Boulevard during the construction of the Redline Subway in Los Angeles.

When the construction inspection function is outsourced to a private company, there is no longer a representative of the public inspecting the work as it is being performed. David M. Walker, the former Comptroller General of the United States from 1998 to 2008, described the issue in a 2007 *New York Times* article: “There’s something civil servants have that the private sector doesn’t, and that is the duty of loyalty to the greater good – the duty of loyalty to the collective best interest of all rather than the interest of a few. Companies have duties of loyalty to their shareholders, not to the country.”

Cost Comparison Prior to Outsourcing

The second provision we would recommend for inclusion in the surface transportation reauthorization is a requirement that state and local transportation departments perform a cost comparison analysis prior to outsourcing work. Specifically, we would suggest the following language:

“For architectural, engineering, and related services on surface transportation projects using Federal funds, a government agency shall prepare an estimate of the cost of procuring the services under a private contract and an estimate of having the services performed by employees of the government agency. A contract shall not be awarded if employees of the agency can perform the services at less cost.”

Increasingly state and local transportation agencies are spending hundreds of millions of federal dollars on private contracts for architectural, engineering, construction inspection and related transportation services without determining whether these contracts are cost-effective, result in safe construction projects, or in any way serve the public interest. This cost comparison proposal will ensure that taxpayers receive safe, high quality transportation services at the best possible price.
